#### Overview

- To assist with questions about processing Wires
- Incoming Wire requests are received Monday Friday, 8:30am 5:30pm EST. Wires must be processed by 3pm for same day processing, after 3pm wires received will be processed next business day
- All international wires are processed daily Monday Friday, 8:30am 3:00pm EST
- Wet signatures are required on a wire agreement form for wires over \$50,000. Please visit:

- Beneficiary Name
- Beneficiary Address
- Beneficiary Account Number
- Amount of Wire
- Name of Financial Institution
- Financial Institution ABA or Routing Number
- Any other information needed for processing the wire

## **Request to Process an Outgoing International Wire**

## The following information is needed:

- Name of Country receiving wire
- Amount of Wire and currency
- Beneficiary Name
- Beneficiary Address
- Beneficiary Account Number or IBAN
- Name of Financial Institution
- Swift code for Financial Institution
- Purpose of Wire
- Any additional information such as Sort Code/Financial Institution #
